TENDER NOTICE

- 1. Fresh sealed tenders under two bid system are invited for hiring of Taxies as reflected in the enclosed tender form on yearly basis for awarding the contract from Jammu based established firms/Agency which are duly registered with Central Government/State Government and having experience for supply of two or more number of vehicle (Non-AC/AC) for day to day, local and out stations (Plain and Hilly areas) operations as per the requirement in the office of Radio Kashmir, Jammu. Both the bids i.e. Technical as well as Financial should be contained and sealed in separate envelops. The bidder should put both these sealed bids in a bigger envelop duly sealed and submit the same by the specific time and date. The rates to be furnished by the tenderers shall include the cost of fuel.
- 2. "TENDER FOR HIRING OF TAXI" should be inscribed on the Top of the envelope meant for submitting Tenders.
- 3. The Tender form along with Agreement form (enclosed as Annexure-I) containing all terms and conditions as specified should be obtained by paying Rs. 500/-(Rupees five hundred only) personally or through representative from the Transport Section of Radio Kashmir, Jammu on any working day between 10:00 a.m. to 05:00 p.m. from the date of publication on CPPP portal. Completed forms in all respects addressed to the Dy. Director General (E), Radio Kashmir, Jammu should reach by 12.00 PM on 06.02.2018
- 4. Tenders will be opened at 03:00 p.m. 06.02.2018 in presence of contractors or their representatives who may wish to come in the chamber of undersigned. In case any holiday is declared by the Govt. on the day of opening the tenders will be opened on the next working day on the same time but the tender box will be sealed on the same day and time as scheduled above
- 5. Tenderer will have to submit earnest money amounting to Rs. 20,000/- (Rupees twenty thousand only) in the form of CDR/DD drawn in favor of Drawing & Disbursing Officer, Radio Kashmir, Jammu along with the Tender without which the Tender will not be considered.
- 6. Vehicles to be supplied shall be of model year 2015 or above.
- 7. Self attested copies of the following documents should be submitted along with the duly completed tender form:
 - i) Registration certificate from appropriate competent authority in respect of supply of transport service.
 - ii) IT Return for the last two year.
 - iii) Experience Certificate
 - iv) copy of PAN/TAN/GST no. GST no is to be provided, if not obtained, the same should be certified with suitable reason by the bidder.

ANNEXURE I

AGREEMENT FOR HIRING OF TAXIS

This Agreement made on the ______ day of ______ between the Radio Kashmir, Jammu, hereinafter called the 'Government', on the one side and Shri/M/s. hereinafter called the 'Supplier' on the other side.

Whereas the supplier is dealing in taxi service, the supplier agrees to provide vehicles as and when required on day to day basis by Radio Kashmir Jammu on terms and conditions set forth hereinafter.

- 1. This agreement will commence with effect from _____(the date of its execution)_____.
- 2. The hire charges will be paid in accordance with as approved and accepted to this agreement.
- 3. The supplier hereby affirms that he has under his possession a minimum of 02 taxis registered with the appropriate Transport Authority, all in working order and giving satisfactory service.
- 4. The kilometers of the taxis as may be supplied shall be in working order as per regulation of the appropriate Transport Authority.
- 5. The Inter-State Passenger Tax, if any, shall be borne by the Government on production of State Government receipt in this regard along with the bill of the taxis. But the supplier shall be required to obtain permits for all the out-station trips in advance and no charges shall be claimed by him on this account.
- 6. The Government shall not be responsible during the course of deployment of vehicles from the supplier for any accident, loss or damages, etc., to his vehicles on any account.
- 7. The Government will also be not responsible for any loss of life or any injury to the driver or to any third party during the deployment of the vehicles by the Radio Kashmir, Jammu.
- 8. The supplier will be responsible for loss, or damage, or injury to any person or property, programe material, equipments or any other articles of government or to any member of the staff caused due to negligence of his drivers, or ill-maintenance of the vehicles hired by the Government.
- 9. The supplier shall at all times keep the Government indemnified against all claims, actions, proceedings costs, damages incurred and award and compensation agreed in consequence of any breach for all or any of the covenants and warrants herein contained.
- 10. The drivers will be very polite and punctual and under no circumstances drive the vehicle under the influence of any intoxicating drink or drug. The supplier shall be responsible for the conduct of the drivers. The Government shall have the right to discontinue hire of vehicles if in the opinion of the Head of the Radio Kashmir Jammu by whatever designation such officer is called (the expression Head of the Radio Kashmir, Jammu hereinafter shall convey the same meaning), the behavior of the driver is found objectionable, and his opinion in this regard shall be final and binding on the supplier.
- 11. It will be the responsibility of the supplier to see that his driver possesses valid license and the supplier will also be responsible in case of a Chillan due to violation of traffic rules, or for any other penalty imposed on the driver, or the vehicle for the time being in use.

- 12. The supplier may be required to supply vehicles as per requirement. The vehicle so supplied should be clear from all angle i.e. should have insured, valid permit and possess a pollution certificate and fulfill all requirements as per rules.
- 13. The extra expenditure if any, that the Government may have to incur due to non-supply of requisite numbers of vehicles to Radio Kashmir Jammu will have to borne by the supplier and the amount in question will be recovered from the supplier by making adjustment against any amount due to the supplier or from the security money deposited by the supplier under clause 16 of this Agreement. The balance amount, if any shall be recovered from the supplier in the normal course of law.
- 14. The supplier agrees to maintain an account of journeys performed by each vehicle as per Requirements of the Government and submit the same to the Head of Radio Kashmir Jammu or his nominee, next day. The supplier shall comply with the requisition for taxi(s) made by the officer nominated by the Head of Radio Kashmir Jammu hereinafter called the ''Said Officer''.
- 15. The supplier agrees to depute a representative to personally collect a Requisition Order for the number of vehicles ordinarily required for the next day from the Said Officer of the Radio Kashmir Jammu. The Said Officer shall have right to place further requisition orders for additional number of taxis. The vehicles shall report at the reception/transport section of the Radio Kashmir Jammu at the stipulated hours and shall remain available up to stipulated hours as indicated from time to time by the Said Officer. The Said Officer shall have the right to detain the taxi beyond stipulated hours without giving prior notice.
- 16 Mileage will start and terminate at the Radio Kashmir Jammu. No mileage shall be allowed for any lunch and tea break.
- 17. The supplier shall be bound by the rates quoted by him and agreed upon herein and period this agreement remains in force . Should the supplier wish to discontinue the Agreement in the event of any increase in Petroleum Oil and Lubricants he shall have right to cancel this Agreement after giving 40 day's notice to the government to make alternative arrangement . In such event the Agreement shall cease to have effect on the expiry of 40 day's form the receipt of the notice.
- 18. The performance security for an amount of ten percent of the value of the contract will have to be deposited in the name of Drawing & Disbursing Officer, Radio Kashmir, Jammu.
- 19. This Agreement shall remain in force for a period of one year from the day this Agreement is made.
- 20. The Head of Radio Kashmir Jammu reserves the right to terminate this agreement at any time without giving any notice on account of breach of any of the conditions stipulated in this Agreement on the part of supplier.
- 21. The decision of the Head of Radio Kashmir Jammu in respect of the terms of the Agreement as aforesaid shall be final and binding on the supplier.

22. The Government agrees to bear the stamp duty, if any payable on this Agreement.

- 23. Provided always and it is hereby expressly agreed that if at any time there shall arise any dispute, differences, doubt or question with regard to the interpretation or meaning of any of the terms and conditions of this Agreement or in respect of the rights, duties and liabilities of the parties hereto or in any way touching or arising out of these presents or otherwise then, every such dispute, difference, doubt or question (except the decision whereof is hereby expressly provided for) shall be referred to the sole arbitration of the person appointed by the Dy. Director General, Radio Kashmir Jammu or if his designation is changed or his office is abolished, the officer who for the time being may be entrusted, whether or not in addition to other function, with the functions of the Dy. Director General, Radio Kashmir Jammu by whatever designation such officer may be called. It will be no objection to any such appointment that the person appointed is a Government servant or that in the course of his duties as such as Government servant he/she has expressed views on all or any of the matters in dispute or difference. The decision of the arbitrator shall be final binding on the parties to this agreement. The provisions of the Indian Arbitration Act, 1940 or any statuary notification or re-enactments thereof and the rules made therein under for the time being in force shall apply to such arbitration' and these presents shall be deemed to be submission to arbitration within the meaning of the said Act.
