I. Liquidated Damages:

If the supplier/contractor is unable to complete the supply of stores/execution the work within the stipulated time limit, the indenter may at his own discretion allow such additional time as he may consider justified with or without liquidated damages and without altering any other terms and conditions of the order. In the event of the failure of the contractor to complete the supply of stores/work of the within the stipulated time or extended time, the DDG (E) AIR Lucknow shall have the right to impose a liquidated damages **@ half percent (0.5%) per week or the part thereof** of the order value.
