The cover should be super scribed with the following details:-

1. Material for which the tenders are enclosed.
2. Reference to the letter of enquiry.
3. Opening date of quotation.

Quotation received without proper wax sealing may be rejected.

- B. The quotation should specifically and clearly mention the following:

1. The make of the material.
2. The delivery period.
3. Forwarding and freight charges up to destination in Rs.
4. Any other charges in Rs.

Tenders with entries as extra without giving details may be rejected. Any additional charges if claimed after opening the tender will not be admissible.

- C. GSTIN: The tenderer should quote GSTIN separately. They should furnish their GSTIN in quotation. Tender with GSTIN included without giving details may be rejected.
