
Subject:- Contract Hiring and installation of CCTV Camera in DG: All India Radio.

DG:AIR invites e-Tender for one year contract for hiring and installation of CCTV Camera in Directorate General, Akashwani Bhawan, New Delhi and various offices of All India Radio located in Delhi as per the terms and conditions mentioned in Annexure-A. Interested firm based/operating in Delhi/NCR and fulfilling the following eligibility conditions are invited to submit their tender:-

- i) Tenderer/Firm should have a minimum annual turnover of Rs. 10 Lakh during the last 3 consecutive years, i.e. in the year 2015-16, 2016-17, and 2017-2018.(ITR and related documents to be submitted)
 - ii) Tenderer/Firm should have experience in successfully executing similar contracts with PSUs and/or Govt. Departments/MNC/reputed organizations during the preceding 3 years , i.e. in the year 2015-16, 2016-17, and 2017-2018(Proof to be enclosed)
 - iii) A Self attested copy of PAN Card/GST Registration Certificate of the bidding firms may be enclosed.
 - iv) Self-certificate that the firm has not been blacklisted by any Central Government Ministry/ Department/PSU/Bank etc. should be enclosed.
 - v) The service providers should have their own Bank Account. (A certified copy of the account maintained for the last three years may be enclosed).
2. Tenderer/Firm may submit their e-tenders in a two bid system i.e. Eligibility Bid as per Annexure-B1 and financial Bid as per Annexure-B2 latest by 03:00 PM on 16.08.2019. The bid should be accompanied by Earnest Money deposit (EMD) of Rs. 4000 (Rupees Four Thousand only) in the form of Bank Draft drawn in favour of "PB,BCI, DG: All India Radio".




