- (i) Agency shall have relevant experience of having provided similar services.
- (ii) The bids are invited into two parts, i.e. **Qualifying/Technical Bid and Financial Bid**. The qualifying/Technical bid should be consisting of all technical details along with commercial terms and conditions as per the proforma at **Anneure-1**. The financial bid shall be as per proforma at **Annexure-II**
- (iii) The Technical Bid and Financial Bid should be sealed by the bidder in separate envelops duly superscribed and both these sealed covers are to be put in a bigger cover which should also be sealed and duly superscribed Quotation for CCTV system on hiring basis for AIR, Delhi. Sealed quotation should be addressed to Sr. Administrative Officer, All India Delhi, Broadcasting House, Room No. 46, Parliament Street, New Delhi so as to reach on or before scheduled date, along with Earnest Money Deposit of Rs. 20,000/-(Rs. Twenty thousand only) in form of a crossed Demand Draft/pay order drawn in favour of DDO, AIR, Delhi ,payable at Delhi. The tenders received without EMD, incomplete or without supporting document or not agreeing to terms & conditions shall be summarily rejected. Tender Evaluation Committee constituted for the purpose will open the qualifying/Technical Bid of the tenderers on 18.09.2019 at 03.00 PM in the presence of tenderers/representative who wish to be present.
- (iv) If an agency qualifies in the technical bid, its financial bid shall be opened. The financial bid should be in proforma at Annexure-II.
- (v) The Dy. Director General (P)/Head of the office or an officer authorised to do so, reserves the right to accept or reject any & all tender(s) without assigning any reason(s) thereof.
- (vi) Canvassing/interfering whether directly or indirectly, in connection with the tender is strictly prohibited and the tenders submitted by the firm will be liable to rejection.

Any damage done/caused to the existing structure/furniture/fitting/equipment of this office, by the workers of the contractor shall be got rectified by the contractor at his own cost or will be deducted from contractor's bills.
- (x) This office premises consisting of heritage building, recording studios, broadcasting studios hence regular visit of VVIPs, Eminent personalities, Senior Govt. Officials, Senior artist and others are always expected. The work should be carried out as per norms/standard and in such a manner that all premises always look neat & clean. All workmen deployed by firm should be decent at their behaviour, work and presence.
- (xi) The rates should be inclusive of all taxes except GST which should be quoted extra.
