

iii) The Earnest money of Rs.5000/-(Rupees five thousand only) in the form of Demand registration. Draft in favour of Station Director, All India Radio, Mumbai.

iv) Quotation in rupees for the respective items mentioned in Annexure-II

v) The unrealistic rates viz, free of cost / complementary / fraction of rupees etc. shall not be entertained and reasonability of rate shall be ascertained according to the item of works.

vii) The tender has to be accompanied by an Earnest Money)' Deposit of Rs.5.000/-(Rupees Five Thousand only) in the form of Demand Drain in favour of Station Director, all India Radio, Mumbai from any scheduled commercial Bank. If the successful tenderer declines to act or withdraw/amend their quotations after opening of Tenders, the EMD shall stand forfeited without any notice to the tenderer and no claim on this account shall be entertained. The EMD of unsuccessful tenderer shall be returned /refunded after finalisation of the contract.

3. SCOPE OF WORK: Repair & Spray painting of Steel Cupboards, Lockers & Tables

4. TERMS & CONDITIONS:

In case of any deficiency in service, a penalty of 10% of the bill will be imposed on the firm. The decision of the Addl. Director Genereal (P)/ Head of Office, All India Radio,

Mumbai in this regard shall be final and binding.

The Addl. Director General (P)/ Head of Office, All India Radio, Mumbai reserves the 11. right to award the contractor to more than one contractor on common lowest rates or split the same. The contract shall normally be awarded to the bidder who emerges L1 in majority of the items on common. Minimum rates i.e. the L1 bidder will have to match the L1 rates of other bidders for the items for which his rates are higher.

The Contract shall be for repair & Spray painting of Steel Cupboards, Lockers & III. Tables in the office of the Addl. Director Genereal (P) All India Radio, Mumbai. The tentative details have been indicated in the Tender inquiry letter and the requirement may vary (More or less) as may decided by the office. This shall be kept in view by
