G.S.R.-.... In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Indian Broadcasting (Programme) Service Rules, 1990, namely:-

1. These rules may be called the Indian Broadcasting (Programme) Service (Amendment) Rules, 2018.

- (d) In Rule 7, in sub-rule (6), in clause (b), in sub-clause (ii), the word "Department" shall be replaced by the word "Departmental" and the words "including the discipline" shall be deleted;
- (e) In Rule 13, the words "and in consultation with the Commission" shall be deleted;
- (f) In Rule 14, after the words " the Scheduled Tribes", the words ", the Other Backward Classes" shall be inserted;




