### Ministry of Information and Broadcasting Instructions and Guidelines for Swachhta Pakhwada 2019

### All Media Units - Swachhta Pakhwada of Mol&B

- PIB and its Regional offices, BOC (DAVP, DFP, S&DD), DD, DD News, AIR, AIR
  News, DPD and NMW may provide wide publicity and coverage as well as maximum
  reach and visibility, as per the respective mandate, to M/o I&B's Pakhwada as well as
  to various other Pakhwadas to be observed during 2019, in consultation with the
  Ministries/ Departments concerned, and/ or as per the request received from time to time.
- All Media Units should make suitable efforts for better branding and publicity of Pakhwada activities on Print, Electronic and Social Media platforms.
- As conveyed in the Consolidated Guidelines, all Media Units may invariably go to the next level of implementation of Pakhwada in 2019.
- All feasible efforts should be made to undertake innovative initiatives and for setting up
  of permanent mechanism through new programmes/ schemes for sustainability of
  Swachhta.
- Senior officers may provide personal leadership and intervention in implementation of Swachhta Pakhwada and efforts should be made to include Union Ministers and MPs/local leaders in Pakhwada activities.
- A detailed Action Plan containing proposed date-wise activities may kindly be prepared and forwarded to the Ministry on Email IDs <a href="mailto:soppe.inb@nie.in">soppe.inb@nie.in</a> and sbm.inbministry@gmail.com.
- 7. As was done during Swachhta Pakhwada 2018, the Ministry is in the process of obtaining separate User IDs for Swachhta Samiksha portal (<a href="http://swachhbharatmission.gov.in/SwachhSamiksha/Home.aspx?Ty=se">http://swachhbharatmission.gov.in/SwachhSamiksha/Home.aspx?Ty=se</a>) devised by Ministry of Drinking Water and Sanitation for uploading individual Action Plans and mandatory daily reporting by all Media Units from 16th 31st January, 2019. The credentials for these IDs, if renewed, will be shared shortly through Email.
- 8. Any related picture album, videos, audio-visual clips, newspaper clippings, press notes, special document, etc. may also be uploaded through the daily reporting section of Swachhta Samiksha portal and a copy of the same along with copies of Daily Reports may also be forwarded to MoDWS on Email ID <a href="mailto:sk.dushyant@nic.in">sk.dushyant@nic.in</a> and to the I&B Ministry on Email ID <a href="mailto:sbm.inbministry@gmail.com">sbm.inbministry@gmail.com</a>. Activity pictures of High Resolution of 2 5 MB may be uploaded on the portal.

### Additional Activities outlined for Press Information Bureau (PIB)

- PIB may supervise the activities of the Regional units of the Ministry through its Regional
  offices and branches.
- PIB may facilitate the Press Conferences to be organized by various Ministries/ Departments, including M/o I&B, at the culmination of their Pakhwadas, in coordination with implementing Ministries/ Departments. Press Releases may also be issued highlighting the outcome of the Swachhta Pakhwadas.
- During the year 2019, the DPOs concerned of PIB may coordinate with various Ministries/ Departments regarding their respective Swachhta Pakhwada and facilitate the obtaining of content, reports and any other resource made available and sharing the same directly with sister Media Units for wide publicity and coverage.

## Swachhata Pakhwada-2019 Consolidated Guidelines

- Every Ministry/Department should nominate a Joint Secretary as nodal officer for Swachhata Pakhwada related activities, if not already nominated
- Every Ministry/Department to ensure that all their line departments, PSUs, attached offices, organizations and Institutions under them to plan and implement in detail Swachhata Pakhwada
- The Swachhata Pakhwada action plan must be communicated to the MDWS two months
  prior to the commencement of their Pakhwada and the same is to be uploaded in the
  designated on Swachhata Samiksha
  (http://swachhbharatmission.gov.in/SwachhSamiksha/Home.aspx?Ty=se)
- Swachhata Pakhwada plans are required to contain detailed date wise activities. Further
  the Ministries/Departments should ensure that the activities during the Swachhata
  Pakhwada are in accordance with their plans and discussion
- Secretary of the Ministry/Department concerned may organise a VC/meeting with their field formations for dissemination of information and to review the preparedness, before, the Pakhwada begins
- Senior Officers in the Ministry/Department may provide leadership in implementing Swachhata Pakhwada activities effectively
- Parliamentary Committee and other MP Committees may be convened on Swachhata
- Ministries/Departments need to involve Union Ministers, MPs and other dignitaries in Pakhwada activities
- Ministries/Departments may take steps to undertake innovative initiatives during the campaigns so that few stories are generated daily
- Divyang access to the toilets to be reviewed and ensured in the Central and State offices
  of Ministries/Departments during Pakhwada
- Ministries/Departments may consider setting up permanent mechanism through new programmes and Schemes for sustainability of Swachhata, in addition to cleanliness drives during the Pakhwada
- There needs to be a daily reporting of the activities during the Pakhwada on Swachhata Samiksha portal (http://swachhbharatmission.gov.in/SwachhSamiksha/Home.aspx?Ty=se) and myGov portals
- Activity pictures of High Resolution of 2mb-5mb to be uploaded on the portal
- During the Pakhwada Ministries/Departments may initiate Swachhata Awards/ranking among organisations under their fold (Detail guidelines are mentioned as Annexure)
- Ministries/Departments should ensure better branding and publicity of Pakhwada activities in electronic and print media platforms at both field and central level. They need to make use of social media such as myGov., Twitter and Facebook extensively for the purpose

Dear Amit,

As you are aware, Swachhata Pakhwada is one among the various Swachhata Initiatives of the Hon'ble Prime Minister. On many occasions, Hon'ble PM has reiterated that the Pakhwada should not to be treated as a routine fortnight but should be fifteen days of solid and substantial work on Swachhata. The objective behind Swachhata Pakhwada is to engage everyone and mainstream Swachhata within the non-sanitation Ministries.

- 2. I have the pleasure to inform you that your Ministry has been allocated the 2<sup>nd</sup> fortnight of Jan 2019 for observing Swachhata Pakhwada next year as is the case in current year. Our standing guidelines on observance of Swachhata Pakhwada is attached for your ready reference. The Pakhwada guidelines prescribe the Ministries and Departments to involve all of their institutions, autonomous bodies, subordinate offices and field formations during the fortnight. In order to encourage them, Swachhata awards may be instituted at all levels during the fortnight besides the three national level top awards sponsored by this Ministry. I request you to upload the Swachhata Pakhwada action plan well in advance on the dedicated portal (<a href="https://swachhbharatmission.gov.in/SwachhSamiksha/index.aspx">https://swachhbharatmission.gov.in/SwachhSamiksha/index.aspx</a>) and progress on the action plan be uploaded on a day to day basis on the same portal.
- 3. During the Pakhwada period, it is suggested that among other things, DD and its various channels and AIR may air our Darwaza Band and Twin pit toilet (featuring both Akshay Kumar and Amitabh Bachchan) campaigns on pro bono basis. Various programmes such as panel discussions on Swachhata, live Swachhata Chaupals, special Swachhata talk shows/ discussions, special features may be run on DD and AIR, more so on regional channels. Various institutes of the I&B may conduct workshops, thematic productions etc. on the subject of Swachhata and also take up Shramdaan activities around their campus. DPD may bring special publications on swachhata during this period and Department of Field Publicity and Song & Drama Division may show swachhata related messages in rural areas. A formal press conference by the Minister/Secretary at the end of the Swachhata Pakhwada may be organized to highlight the work done during 16th 31st January 2019.
- I wish you all the very best for a successful observance of your Swachhata Pakhwada.

  - 3. Any special document that Ministry/Department may have issued during Pakhwada
  - 4. Name and details of the three Swachhata Pakhwada awardees

### Annexure

### Swachhata Pakhwada Awards - Guidelines

- Each Ministry/ Department observing the Pakhwada will be provided three awards from Ministry of Drinking Water and Sanitation. However, Ministries/Departments may encourage to introduce large number of awards at their level to encourage Swachhata Pakhwada activities
- 2. The awards would be given to those who have contributed maximum to the cause of sanitation on the basis of rating and ranking. Emphasis while giving the awards would be given to innovative/ creative activities & initiatives, mass mobilization for Swachhata, engagement of varied sections outside the organization etc. which have deep and sustainable impact, countrywide
- Each Ministry/ Department would carry out the selection process overseen by the concerned Secretary and select the final three (First, Second and Third) awardees and intimate MDWS within the two days of ending of their Pakhwada
- -4. These awards would be handed over to the winning sections/ attached offices/ field formations/ Institutions/ PSUs/ organizations at the end of Pakhwada Press Conference or similar events
- Ministries and Departments are requested to send the list of the selected winners to the Ministry along with a brief note mentioning the basis for the same to Shri Kapil Chaudhary, Director, MDWS (<u>kapilc1973@gmail.com</u>)
