CIRCULAR

Subject: Release of provisional pension and other retirement benefits-Regarding

It has come to the notice of this Directorate that stations/Kendras are adopting dissimilar method while granting pension and other pensionary benefits to the retiring programme officers.

2. In this regard, attention may be drawn to two orders of court/tribunal pronounced in respect of pay related matters. In OA/100/2483/2018 and pronounced in respect of pay related matters. In OA/100/2483/2018 and MA/100/2777/2018 clubbed with OA No. 1974/2015, Kumud Malik & MA/100/2777/2018 clubbed with OA No. 1974/2015, Kumud Malik & others vs. MIB, the Hon'ble CAT. Principal Bench, New Delhi passed an others vs. MIB, the Hon'ble CAT. Principal Bench, New Delhi passed an order dated 06:07.2018 that there will be stay of the DG:AIR's impugned order dated 07.04.2015 in respect of wrong stepping up of pay of DR PEXs and recovery thereof.

The other order, which may also be referred to, is pronounced in a case related to grant of benefit under ACP Scheme. The Hon'ble CAT, Principal Bench, New Delhi in MA/100/2681/2018, OA/100/3046/2015 and MA/100/2677/2015, PSA vs. MIB passed an order dated 26.06.2018 to MA/100/2677/2015, PSA vs. MIB passed an order dated 26.06.2018 to maintain status quo in respect of fixation of pay as well as recovery. maintain status quo in respect of fixation of pay as well as recovery. In view of the observation of the Pay & Account Office, DG: AIR has granted only provisional pension to the retirees of Programme Cadre i.e. PEX/ADPs.

3. In view of above two orders, while dealing with the pension cases, the Pay & Account Officer has accorded the sanction of provisional pension only until the final judgment is delivered by the Hon'ble Court. As regards other pensionary benefits the PAO has agreed to release the amount accrued under CGEGIS only.
