- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he consider himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website <https://prasarbharati.eproc.in>, or www.eprocure.gov.in free of cost.
- The bid can only be submitted after depositing of offline EMD and online processing Fee in favour of C1 INDIA PVT. LTD. and other documents as specified. Necessary instructions to bidders-online mode is also attached with this NIT, However it will not be the part of the agreement. Unless all intending tenderer/bidders who have uploaded/submitted their bids by the last date of tender have submitted their online EMD which is verified from the issuing bank, tenders cannot be accepted and to be treated as invalid tender.
- Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
- The intending bidder must have valid class-III digital signature to submit the bid. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- The price bid shall be opened after verifying the documents. However, bidders shall have no option to submit the revised price bid, if so, desired by them. The price bid submitted earlier shall remain valid and opened on due date.

8. Contractor can upload documents in the form of **ZIP** format and **PDF** format.
9. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
10. The contractor shall quote rates including work contract GST, other taxes, Cess and levies. However, GST shall be reflected in the tax invoice / bill separately.

List of Documents to be scanned and uploaded within the period to tender submission.

The following documents should mandatorily be uploaded so as to reflect in the front box of verifying documents of the tender site.

1. Valid enlistment order of the Contractor/Agency.
2. EMD payment will be offline through Prasar bharti E-procurement portal.
3. Affidavits as per Clause 1.2.2 of CPWD-6 on non judicial stamp paper of Rs 100/- duly Notarized. (Notarization shall be done after the date of uploading/publishing of NIT).
4. Partnership deed (if any) and power of attorney (if any) in the name of authorized partner/ representative.
5. Copy of Bidder PAN card.
6. Certificate of registration for Goods and Services Tax. If the bidder has not obtained GST registration of Delhi State, the bidder shall upload following **undertaking on Non judicial stamp paper of Rs 100/- duly Notarized** with bid Documents. (For bidders having GST registered in Delhi, no undertaking as mentioned below is required.)

(It is mandatory to upload scanned copies of all the documents, if one of these documents is not uploaded, then bid will become invalid and shall summarily be rejected).

The bidder shall be required to produce original documents for verification on demand by Assistant Engineer (Civil).
