(B&R) for the following works:

1. The intending bidder must read the terms and condition of CPWD 6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and instructions for bidders posted on web site shall form part of bid document.
3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen **and downloaded** from website www.tenderwizard.com/AIR free of cost.
4. But the bid can only be submitted after depositing processing fee in favour of ITI Limited and uploading the mandatory scanned document such as Demand draft or Pay order or Banker's cheque or Deposit or Call receipt or Fixed deposit receipts and Bank guarantee of any schedule bank towards EMD in favour of The Executive Engineer (Elect.) Civil Construction Wing, All India Radio, Bengaluru-560001 and other documents as specified.
5. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the Website

6. The intending bidder must have valid **class-III** digital signature to submit the bid.
7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
8. **Contractor can up load documents in the form of JPG format and PDF format.**
9. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in yellow colour and the moment rate is entered, it turns sky blue.
In addition to this, while selecting any of the cells a warning appears that if a any cell is left blank the same shall be treated as "0".
Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO)
10. SC / ST contractors enlisted under class –V are exempted from processing fee payable to ITI limited.
11. The prices quoted by the tenderer shall be firm for the entire contract period. Prices shall be inclusive of all taxes and duties including GST as applicable.
