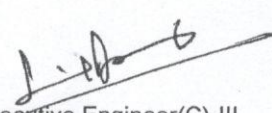

2. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he consider himself eligible and he is in possession of all the documents required.
3. Information and instructions for bidders posted on website shall form part of bid documents.
4. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/AIR free of cost.
5. (i) But the bid can only be submitted after updating mandatory details such as Demand Draft or Pay order or Banker's Cheque Deposit or call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards EMD in favour of Executive Engineer(C), CCW, AIR, Div.-III, P.B., B.C.I. New Delhi and Processing Fee (as applicable) payment should be made through online mode only.
(ii) The amount of EMD can be paid by multiple Demand Draft/Pay Order/Banker's Cheque/Deposit at call receipt/FDR's along with multiple Bank Guarantee of any schedule bank, if EMD is also acceptable in the form of Bank Guarantee.
(viii) Detailed procedure can be seen in the CPWD -6 for e-tendering.
6. Those contractors not registered on the website mentioned above, are required to get registered before hand. If needed they can be imparted training on online bidding process as per details available on the website.
7. The intending bidder must have **valid class -III digital signature** to submit the bid.
8. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
9. Contractor can upload documents in the form of JPG format and PDF format.
