



f. Mode of payment:-

You will submit the consignee wise Tax invoice as per Clause 15(c). The GST Compliant Invoices should have firm's GSTIN & Consignee GSTIN and Invoices will be raised State GSTIN wise, (A list of GSTIN no of concerned states are enclosed) so as to enable Prasar Bharati to avail the GST credit on any indirect tax viz Goods & Services tax including CGST, SGST, UTGST, IGST, applicable cess and any other taxes applicable.

If the supplier registered under the GST regime as normal tax payer and does not show the detail(s) of invoice(s) raised on Doordarshan in his GSTR-1 for that month, Doordarshan may claim input tax credit by making entries of such invoice(s) in GSTR-2 under intimation to the supplier with a request to upload the detail(s) of these invoice(s) in his GSTR-1. In case no entry(ies) is reflected in next month GSTR-1 filed by the supplier due to which ITC claimed earlier is disallowed, Doordarshan will be free to recover the amount of GST so paid to supplier along with penalty @10% plus applicable GST there on from the subsequent payment or from PBG given by the supplier without giving any notice.

g. Terms of Payment:

90% of payment shall be allowed on proof of receipt of material as recorded in Provisional Consignee receipt certificate and submission of Security Deposit as certified by DG: DD. The balance 10% will be payable after final acceptance of the entire stores by the consignee as recorded in his final receipt certificate.

In case of over payment or wrong payment, if any, made to the contractor due to the wrong interpretation of the provision of the contract, or otherwise, such excess payment will be deducted in subsequent bills of the contractor or from the bills under any other contracts of the organization or from deposits of any contracts available with this organization.

h. Transit Insurance:

The purchaser will not pay separately for transit insurance and the supplier will be responsible for arrival of the entire stores contracted for in good condition at destination. The consignee will, as soon as possible but not later than 30 days of receipt of stores, notify to the contractor for any loss/damage to the stores that may have occurred during transit.

i. Other Statutory/ Local Tax etc.

In case, any Municipality insists on payment of taxes or duty, the same should be paid by the contractor to avoid delay in the supplies and possible demurrage charge. The receipt obtained for such payment should be forwarded to **Bill Processing Authority** without delay, For processing of payment. The **Bill Processing Authority** will check the claims with reference to the vouchers and counter sign the bills to authorize the payment.

j. Guarantee/ Warranty:

The following guarantee/ warranty shall form part of this contract: -

The contractor/seller hereby declares that the good, stores/articles sold/supplied to the purchaser under this contract shall be of the best quality and workmanship and new in all respect and shall be strictly in accordance with the specification and particulars contained/ mentioned in contract. The contractor / seller hereby guarantees that the said goods/stores/articles would continue to conform to the description and quality aforesaid for a period of **36 months** from the date of commissioning of the said goods/stores/ articles to the purchaser notwithstanding the fact that the purchaser (Inspector) may have inspected and/or approved the said goods/stores/articles if during the aforesaid period of **36 months** the said goods/stores/articles be discovered not to conform to the description and quality aforesaid or not giving satisfactory performance or have deteriorated and the decision of the purchaser in that behalf shall be final and binding on the Contractor /Seller and the purchaser shall be entitled to call upon the contractor/seller to rectify the goods/stores/articles or such portion thereof as is found to be defective by the purchaser within a reasonable period, or such specified period as may be allowed by the purchaser in his discretion on an application made thereof by the contractor/ Seller, and in such an event, the above mentioned guarantee/ warranty period shall apply to the goods/stores/articles rectified from the date of rectification thereof, otherwise the contractor/seller shall pay to the purchaser such compensation as may arise by reasons of the breach of the warranty herein contained.

- (i) Guarantee that they will supply spare parts, if and when required on agreed price. The agreed basis could be including but without any limitation and agreed discount on the published catalogue or an agreed percentage of profit on the landed cost.

- (ii) Guarantee to the effect that before going out of production of the spare parts, they will give sufficient adequate advance notice to the purchaser of the equipment so that the latter may undertake the balance of the lifetime requirements.
- (iii) Guarantee to the effect that they will make available the blueprints of the drawings of the spares if any when required in connection with the main equipment.
- (iv) Any equipment failing during the guarantee period shall be repaired/replaced free of charge by the supplier at site i.e. no transportation charges would be paid by DD for transporting the defective equipment, if required to be removed from the site, during the guarantee period.
- (v) a) The guarantee includes all hardware, software and modules of the complete system.
b) The firm will provide up gradation of all the offered software free of charge during the warranty period.
- (vi) Guarantee period is to be extended corresponding to the outage period if the failure rectification takes more than 15 days time.

k. After Sales service:

It is a condition of the contract that the contractor shall be responsible for after-sales-service for minimum period of **24 months** after the completion of Guarantee/Warranty period shall also be provided by the OEM either directly or through their local agent.

l. Correctness and completeness of stores:

The stores will be completed in every respect with mountings fittings, fixtures and standard accessories, which are normally supplied even though not specifically mentioned in the specifications. The contractor shall not be eligible for payment in respect of such mountings fittings, fixtures and standard accessories, which are needed for safe operation of the equipment. The contractor shall be responsible for the completeness of the equipment and for efficient working of the same at site.

- m. The period for making risk purchase shall be nine months instead of six months as provided in sub Para clause 14 (7)(iii) of the General Conditions for the contract DGS&D-68(R).

n. Repeat Order:

Purchaser reserves the right to place order up to 50% of the original quantity of any item(s) on the same terms and conditions stipulated in the original acceptance of tender during the validity of this tender or within six months of the original A/T whichever is later will be obligatory on the part of the supplier to execute repeat order(s) also.

o. Failure and termination:

Liquidated damages to the extent of 1/2% (half percent) of the contract price of the whole unit per week for such delay or part thereof subject to maximum of 10% of the contract price of the whole unit will be deducted from the contract in the event of failure of supply of equipments within the contractual delivery period. The termination of the contract shall be dealt as per terms & conditions of tender document.

p. Mandatory disclosure of recipient (Doordarshan's) GSTIN on invoice:

The supplier should quote the GSTIN of the concerned unit of Doordarshan as mentioned in Annexure "A" of AT, on the face of the invoice and in GSTR-1 filed by the vendor. If the above GSTIN number is not quoted on the invoice, the amount equal to the extent of ITC amount will be deducted in the payment or will be deducted in subsequent bills of the contractor or from the bills under any other contracts of the organization or from deposits of any contract available with this organization.

- q. In case any credit, refund or benefit is denied or delayed to Doordarshan due to non-compliance by the contractor (e.g: non payment of GST on supplies, non-disclosure or incorrect disclosure in GST returns), the contractor would reimburse an amount equivalent to the loss including, but not limited to tax loss, interest and penalty to Prasar Bharati.
