Subject:- Quotation for Painting of 100 meter Self Supported Tower of FM Transmitter at All India Radio, Dharamshala (HP). Job includes the supply of all the material, labour, tools etc.

Period for completion of work : 30 Days after the award of work.

TERMS AND CONDITIONS & SPECIFICATIONS:

- Name of Job:** Painting of 100mtrs self supported Tower of FM Transmitter at AIR Dharamshala. Job includes supply of all the material, labour, tools etc.
- Eligibility of Firms:** Only those firms which have completed at least 3 such works of similar nature in past will be considered eligible. Tenders from firms not qualifying this criterion will be rejected. Proof to this effect may please be submitted along with the Tender.
- Time allowed during the day for the painting:** 10AM to 5PM subjected to the condition of good visibility. Painting would not be carried out under the conditions in which water is liable to condense on the surface. However, working hours will be restricted to one hour per day(1100hrs. to 1200hrs.)on the portion of the tower where antenna is mounted.
- Painting of Mast:** The tower should be painted in alternative bands of international orange and white terminating with orange band both at top and bottom. The band should be perpendicular to the longest dimension and have a width of approx. 1/7 of longest dimension of tower. The orange and white band should be equal width.
- Preparation of surface:-** All dust, dirt grass and rust if any, should be thoroughly removed with suitable cleaning agent. After removing the dirt the surface should be thoroughly cleaned where the original paint peeled off and GI sheet is visible. The surface prepared shall be applied with finest sand paper suitable for GI metallic surface. After degreasing and cleaning when the surface is dry, without too much delay a coat of zinc chromate primer shall be applied. The primer coat shall be allowed to dry for a minimum of 72 hours before application of next coat of paints.
- Coats of Paint:** Two coats of paints shall be applied. The first coat shall be allowed to dry for at least 72 hours before the second coat is applied. The painting coat of high quality exterior gloss paint shall be applied. The practice of mixing kerosene oil with paint is strictly forbidden.
- Specifications for painting:** The primer, paint and thinner used should meet the under mentioned specification:-
IS-2074-1962: Ready Mix paint Metal priming.
IS-2932-1964: Synthetic enamel exterior type paint.
IS-1745-1961: Petroleum Hydrocarbon Solvents (Thinner).

All the paints for the different coats shall be compatible with each other and shall be of the same make.

8. **EMD:-** The tender shall be accompanied by earned money of ₹1000/- (Rupees One Thousand Only) in the form of demand draft in favour of SE, Prasar Bharati, All India Radio, Dharamshala(HP). Tenders without EMD shall be summarily rejected and their bid will not be opened at the time of tender opening and returned to bidder unopened.
9. **Security Deposit:-** Security Deposit at the rate of 5% to be furnished by successful tenderer. The security deposit shall be furnished in the form of Demand Draft/Bank Guarantee drawn in favour of SE, Prasar Bharati, All India Radio, Dharamshala(HP). The Security deposit will be returned in full on completion of successful Guarantee/warranty Period.
10. **Guarantee/warranty:** 03 months after successful completion of work. During guarantee period, the contractor shall repair or replace free of charge any parts that will become defective due to faulty material design, workmanship.
11. **Contractor liability during work:-**
- The department shall have no liabilities against any mishap during execution of work. All such liability is of the contractor. Contractor must obtain all statutory compliance & insurance etc. before start of the work and valid beyond the completion period.
 - Any compensation against the workman compensation act shall be sole liability of the contractor.
 - The contractor will be fully responsible for any physical injury/loss of life of any person employed by him. In case of any accident, while carrying out the work covered in the contract. The department will not be in any way responsible and the contractor will have to take all the necessary precaution/adopt safety measures while working on high structure/Tower.
 - The contractor will be responsible for safe handling of antenna and feeder cable which are delicate in nature. While handling/fixing etc. in the event of any damaged partly or fully to any of these equipments, the contractor will have to bear the cost of damaged equipment.
 - The contractor shall make his own arrangement for procuring the necessary labour, skilled and unskilled. He should conform to all local state laws and regulation concerning labour and their equipment.
 - The contractor shall indemnify and hold harmless the authority against all claims in respect of injury to any person howsoever arising out of the painting work.
 - The contractor shall discuss the painting procedure and the time frame with the site in-charge at site and the painting shall be done in co-ordination with him.
 - The Firm has to produce a list of all such workers along with the addresses which are to be deployed for the job on signing of contract. The Firm shall issue the identity cards to all such persons to facilitate the entry in office complex.
 - The contractor will have to sign the terms and conditions of work contract and agreement for responsibility of all the men at work etc. before start of work in the affidavit form.
 - The rates quoted for the complete job will be taken for comparison and not in parts.
