- 1. As per terms & conditions your expert technical person will visit on 1st Monday of every month for routine and preventive maintenance of engine, alternator, and self- battery charges etc. After preventive maintenance in each month, he will test the Diesel Set on full load and then handover the DG Set to Technical Staff All India Radio. He will take a Certificate from our Tech. Staff during visit of every month that "Maintenance Work of complete DG Set has been done satisfactory" this certificate will be attached along with the quarterly bill of
- 2. In case of breakdown DG Set, Technical Staff of the firm will attend the breakdown within 6 hrs. of reporting of breakdown to the firm on telephone. In case of delay a fine of R. 500/- per day will be imposed on the firm
