### NOTICE INVITING e - TENDER

- 1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents as required.
- The bid document consisting of specifications, the schedule of quantities of various types of items
  to be executed and the set of terms and conditions of the contract to be complied with and other
  necessary documents can be seen and downloaded from website <a href="www.tenderwizard.com/AIR">www.tenderwizard.com/AIR</a> free of
  cost.

- Those firms/ agencies not registered on the website mentioned above are required to get registered
  with <u>www.tenderwizard.com/AIR</u>. If needed they can be imparted training on online bidding process
  as per details available on the website.
- 4. If any information furnished by the applicant is found incorrect at a later stage, he will be debarred from tendering / taking up the work. The department reserves the right to verify the particulars furnished by the applicants independently.
- 5. But the bid can only be submitted after uploading the mandatory scanned documents such as Demand Draft or Pay order of Banker's Cheque or deposit at call Receipt of fixed deposit Receipts and Bank guarantee of any Scheduled Bank towards EMD in favour of respective Executive Engineer and processing fee in favour of ITI Limited and other documents as specified. A part of earnest money is acceptable in the form of Bank Guarantee also. In such cases 50% of earnest money or Rs. 20 lakh whichever is less, will have to be deposited in shape prescribed above and balance can be accepted in form of Bank guarantee issued by a scheduled Bank.
- 6. On opening date, the contractor can login and see the bid opening process .After opening of bids he will receive the competitor bid sheets.
- 7. The intending bidder must have valid class-III digital Signature to submit the bid.
- 8. Contractor can upload documents in the form of JPG format and PDF format.
- 9. Firms/ agency must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink color and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate quoted by the bidder, rate of such item shall be treated as "0" [ZERO].
- 10. Documents uploaded by the contractors related with Eligibility Criteria are opened first and name of eligible contractors are approved by the competent authority.
- 11. Self attested copies of certificate of work experience and other document scanned and uploaded document as specified in Press Notice shall have to be submitted by the successful bidder along with physically EMD in the Office of the tender opening authority for verification from original copies.
- 12. The Department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any numbers deemed suitable by it, if too many bids are received satisfying the laid down criterion.

### The bid submitted shall become invalid if:

- b.
