1	Providing and constructing sloping Profile Sheet roof Shed for 25 KVA Diesel Generator of size as per enclosed Drawing at 5 Nos of LPTV/All India Radio stations at 1) Allagadda(AP), 2) Devarakonda, 3) Sirpur, 4)Ramagundam(Telangana) & 5) Bhagalkot(Karnataka) as per following: <ul style="list-style-type: none"> <li>A) 12' width, 15' Long and height of 11.6' at the centre, sloping on both sides to 10' height at the end as shown in the enclosed Drawing.</li> <li>B) Sloping sides should be given support by matrix of 6 Nos of tubular channels of 3"x 1.5" size and 4 Nos of tubular channels 1.5" x 1.5"size . Tubular channels at the centre has to be joined with 6mm MS Plate fitted with 12mm MS Bolts, nuts &amp; washers.</li> <li>C) Vertical 4 supports through 3" dia pipe has to be provided at the corners.</li> <li>D) Half curved PVC Pipechannel has to be provided at edge of sloping side to drain out the rain water.</li> </ul>	5Jobs (1Each at 5 sites)		


	<p>E) Four Foundation Bolts at a length of 3 feet with suitable dia for each of Vertical supports shall be dig with 300mm x 300mm x 600mm and filled with 1 : 2 : 3 ratio of concrete mixture. The Poles shall be fitted properly with perfect 90 degree angle from the ground.</p> <p>F) Before fixing the top roof, the entire structure shall be painted with one coat of epoxy metal primer and two coats enamel paint properly.</p> <p>G) Corrugated colour Metal Roofing preferable sky blue colour (Similar to Everest) shall be provided with the 1090mm x 3050mm length with a cover width of 1006mm with thickness of 0.45mm(TCT) and strength as per GL SSOMPA as per AS:1397. The Colour metal roofing sheets shall be fitted with proper Clamp</p>

8. GUARANTEE / WARRANTY PERIOD: The Work shall be guaranteed for a period of **1 Year** from the date of commissioning. Any failure in the work carried out, during the Guarantee period shall be repaired / replaced free of charge by the Contractor at the Site.
9. Both your **PAN – Permanent Income Tax Account Number and GST Number** should be definitely indicated in your quotation.
10. **Taxes:** GST leviable and intended to be claimed from the purchaser should be distinctly shown along with prices quoted. Where this is not done no claim for GST will be admitted at any later stage and on any ground whatsoever.

The contractor shall discharge his entire obligation under the Indian Workmen Compensation Act in as far as it affects workmen in his employment.
