It is mandatory for all DDOs of the network to update the profile of all employees in e-Salary module of the Centralized Accounting Software (CAS). Personal Details like Email IDs, Aadhar No, PAN, and Mobile No. are essential part of an employee's profile which is required to be precise and correct in Employee's Profile of e-Salary module of CAS. These details will facilitate the employees to download their salary slips from e-ESS portal; e-ESS is an Employee Self Service portal in CAS to access and download correct salary slips.

It has been observed that the numbers of complaints are being raised by individual employees/ Stations regarding login into e-ESS portal and for not being to change their passwords to access e-ESS portal. In order to ensure that employees will able to login or access the e-ESS portal, every employee requires HRIS no. as a login ID and DOB in the format of ddmmyy as a password. Furthermore, OTP is required to change the old password/forget password, that OTP will be received on the employee's registered mobile number. Therefore, to access e-ESS portal service for all employees, DDOs must ensure to update correct mobile numbers of all the employees in Employee's Profile of e-Salary module of CAS.
