1. Offer form duly filled in.
2. "A" certified films are not eligible for telecast on Doordarshan channels. Proposals in respect of only such films which are having "U", "V/U", "U/A" and "V/UA" certificates can be submitted for consideration. U/A or U/UA certified films can be telecast with cautionary endorsement that the question as to whether a child below the age of 12 years may be allowed to see such a film should be considered by the parents or the guardian of such child.

3. Copy of Link agreement(s), duly notarized on stamp paper, in order to establish that the applicant holds the rights of the film offered by him.
4. Notarized copy of Censor Certificate
5. Synopsis including storyline, star cast and details of director, music director, etc., list of hit song and year of release.
6. Doordarshan Gradation copy.
7. DVD / Pen drive of the film for preview purposes.
8. Indemnity Bond in the prescribed formats.
9. Publicity materials if any.
10. Award certificate / Jubilee certificate, if any, duly notarized.
11. Newspaper clippings / copies of press review wherever available.
12. Photocopy of the PAN card and GST certificate (if registered) of the applicant.

2. **FURTHER** that the 'Obligor' hereby undertakes to keep the 'Obligee' indemnified against any claim, dispute, litigation, and court expenses incurred by the obligee etc. in respect of the TV/Doordarshan rights/Copy rights of the said picture for all India.
3. **FURTHERMORE**, that the 'Obligor' agrees to make available of the film to the 'Obligee' by providing in DVD / Pen drive in MP4 format for the purpose of preview and MXF format for telecast or any other format prescribed by Doordarshan in course of time at his own expenses and it is mutually agreed that the same shall be returned to him after use.
4. **FURTHER**, that in the event of any objection/claim from any distributor/s or negative rights holder/Video rights holder or any party or parties against telecast of the above feature film 'the Obligor' agrees and undertakes to get the objections cleared of his own claim, litigation and/or dispute.
5. **FURTHER**, that in the event of any dispute, this indemnity bond shall be subjected to the jurisdiction of appropriate Court in Thiruvananthapuram.
6. **AND WHEREAS**, the 'Obligee' has expressed his willingness to give royalty to the 'Obligor' in connection with the telecasting of the Feature Film _____ in _____ language over Doordarshan.
