Terms and Conditions

- 1. Rate quoted shall be Labour Cost only and the work will be from main water pipeline source PHED to DDK complex, PPC and staff quarters, Guwahati as on need basis.
- 2. Materials will be supplied by the Office.
- 3. The contractor/Agency must have valid registered GST Number, copies of PAN number should be enclosed along with the quotation.
- 4. At least one previous Experience Certificate/work order must be attached along with the Quotation.
- 5. MSME Certificate should be attached for exemption of EMD/Experience and Turnover.
- 6. The Contractor/Agency who has quoted the lowest shall be awarded the work. L-1 shall be arrived on the total amount for the work.
- 7. No Advance payment shall be made and the agency on completion of work shall submit pre-receipted GST compliant bill, so that payment shall be made by NEFT/ECS mode only directly to their account. No cash payment shall be made in this regard.
- 8. TDS/IT at applicable rate shall be deducted.
- 9. The sealed cover quotations may be submitted to this office super scribed with the detail of contract Enquiry No. and due date in person or by Courier/Speed Post so as to reach this office on or before the due date.
- 10. The due date of receipt of Quotations is 04/10/2023, 11:00 Hrs. and the quotations shall be opened at 15:00 Hrs. on the same day.

- 12. The DDG(E), DDK, Guwahati has all right to accept or reject any quotation without assigning any reason what so ever.

- 13. Legal issues if any raised in connection with this quotation shall be settled under the judicial jurisdiction of Guwahati Metropolitan.
- 14. Payment will be released after successful and satisfactory completion of the work.
- 15. The work in all respect should be completed within the time period as per work order.
- 16. All the tools, equipment's, diesel/petrol generator, welding machine and drilling machine required for the work has to be borne by the contractor.
- 17. The contractor shall take insurance for his men while working at site against any injury, accident and death etc. Similarly the equipment, instruments, tools etc, belonging to the contractor shall be insured against the damage, loss, theft etc.
- 18. While engaging labours for carrying out obligations under the contract, the contractor shall satisfy the conditions laid down under contract labour(Regulation and Audition Act 1970 and (Central) Rules 1971 as amended from time to time and observe all formalities required as per said Act/Rules. The contractor shall also observe the provision under Minimum Wages Act 1948(Central) Rules 1950 amended from time to time while engaging labour.
- 19. The contractor shall indemnify and hold harmless the purchaser against all claims in respect of injury any person howsoever arising out of the work in the course of such work. The contractor shall discharge his entire obligation under the Indian Workmen Compensation Act in as far as it effects workmen in his Employment.
