v)The undersigned has the right to accept or reject the quotation /quotations without assigning any reason.

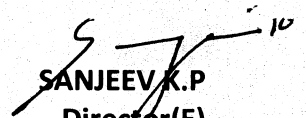
The quotation should be valid for a period of 6 months from the date of opening them.
