Criteria of eligibility for submission of tender documents Two similar work each of value not less than 60% or one similar work of value not less than 80% of the estimated cost put to tender, in last

7 years ending last day of the month previous to the one in which the tenders are invited. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of tender.

Similar work means:- SITC of any type air-conditioning system at least SITC of 1.5 Ton capacity split AC machine with allied electrical works.

- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and instructions for bidders posted on website shall form part of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website <https://prasarbharati.eproc.in> free of cost.
- But the bid can only be submitted after uploading the mandatory scanned documents such as Certificate of work experience/Credential, Demand Draft or Pay order or Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards EMD in favour of **Executive Engineer (E), Civil Construction Wing, All India Radio, Kolkata Payable at Kolkata** and Processing Fee in favour of <https://prasarbharati.eproc.in>, Goods & Service Tax registration and other documents as specified.

INSTRUCTIONS TO BIDDER – ONLINE MODE

DEFINITIONS:

- ❑ **C1 India Pvt. Ltd.:** Service provider to provide the e-Tendering Software.
- ❑ **PrasarBharati e-Procurement Portal:** An e-tendering portal of PrasarBharati introduced for the process of e-tendering which can be accessed on <https://prasarbharati.eproc.in>.

I. ACCESSING / PURCHASING OF BID DOCUMENTS :

It is mandatory for all the bidders to have Class-III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) from any of the licensed Certifying Agency under CCA. Ministry of Electronics and Information Technology, Government of India to participate in e-tendering portal of PrasarBharati. Bidders can see the list of licensed CA's from the link www.cca.gov.in C1 India Pvt. Ltd. also facilitate Class III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) to the bidders. Bidder may contact C1 India Pvt. ❑ To participate in the e-bid, it is mandatory for the Applicants to get themselves registered with the Prasar Bharati e-Tendering Portal (<https://prasarbharati.eproc.in>) to have a user ID & Password which has to be obtained by submitting a non-refundable annual registration charges of Rs. 450/- plus 18% GST through **online** mode (net banking/debit card/credit card). Validity of Registration is 1 year.

❑ The amendments / clarifications to the tender, if any, will be posted on the PrasarBharati e-Tendering Portal (<https://prasarbharati.eproc.in>).

❑ To participate in bidding, bidders have to pay Tender Processing Fee according to the Tender Value per Tender per Bid through online mode viz.

❑ The Bidder may modify or withdraw their bid after submission prior to the Bid Due Date. No Bid shall be modified or withdrawn by the Bidder after the Bid Due Date and Time.

❑ Both 'EMD' and 'Tender Document Fee', if any, are mentioned in individual tender document published at PrasarBharati e-Tendering Portal (<https://prasarbharati.eproc.in>).

❑ It is highly recommended that the bidders should not wait till the last date of bid submission to avoid complications like internet connectivity issue, network problems, system crash down, power failure, browser compatibility issue, system compatibility issue, improper digital signature certificate problem etc. In view of this context, neither Prasar Bharati nor C1 India Pvt. Ltd will be responsible for such eventualities.

A part of earnest money is acceptable in the form of bank guarantee also. In such case, minimum 50% of earnest money or Rs.20 lacs, whichever is less, shall have to be deposited in shape prescribed above, and balance may be deposited in shape of Bank Guarantee of any scheduled bank having validity for 6 months or more from the last date of receipt of bids should be deposited either in the office of Assistant Engineer(E) inviting bids or division office of any Executive Engineer, CCW, AIR within the period of bid submission. The same should also be scanned and uploaded by the intending bidders. (The bank guarantee as EMD should only be issued from the place in which the office of receiving division office is situated).

This receipt of deposition of bank guarantee shall also be uploaded to the <https://prasarbharati.eproc.in> by the intending bidder upto the specified bid submission date and time.
Copy of Enlistment Order and Certificate of work experience and other documents as specified in the notice shall be scanned and uploaded to the e-tendering website within the period of bid submission. However, certified copy of all the scanned and uploaded documents as specified in notice shall have to be submitted by the lowest bidder only within a week physically in the office of tender opening authority.

5. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
6. The intending bidder must have valid Class-III digital signature to submit the bid.
7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
8. Contractor can upload documents in the form of JPG format and PDF format.
9. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink color and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
10. SC/ST contractors enlisted under class V category are exempted from processing fee payable to <https://prasarbharati.eproc.in>.
11. The GST has been implemented by the Government of India with effect from 1st July 2017. The rates quoted by the tenderer shall be firm and inclusive of all taxes, GST etc. as applicable.
12. Tenderer shall examine the various provisions of CGST Act, 2017/IGST Act, 2017/ SGST Act 2017 of the respective State and upto date amendments issued from time to time and other applicable taxes before bidding tendering. The tenderer shall also confirm to the rules made under these Acts.
13. The tenderer shall ensure that benefit of input tax credit (ITC) likely to be availed by them is duly considered by them while quoting rates.
14. The Contractor Shall Submit the invoice of the work executed as per rule 35 of CGST Rules 2017.
15. As Contractor's rates are inclusive of all taxes, no reimbursement of any tax shall be made to the contractor. The clause 37 of GCC of NIT/ Contract stands modified accordingly.

16. TDS on income tax, labour cess and other statutory deductions shall be made at source as per prevalent laws. TDS on GST as & when becomes applicable will also be deducted as per relevant GST Act/rules notification.
17. Earnest Money in the form of Treasury Challan or Demand Draft or Pay order or Banker's Cheque or Deposit at Call Receipt (drawn in favour of **Executive Engineer (E), CCW, AIR, Kolkata**) or Bank Guarantee of any Scheduled Bank shall be scanned and uploaded to the e-tendering website within the period of tender submission.
18. A part of earnest money is acceptable in the form of bank guarantee also. In such case, 50% of earnest money or Rs. 20 lac, whichever is less, will have to be deposited in shape prescribed above, and balance in shape of Bank Guarantee.
19. Interested contractor who wish to participate in the tender has also to make payments in the form of Demand Draft/ Pay Order/ Banker's Cheque of any scheduled Bank and to be scanned and uploaded to the e-Tendering website <https://prasarbharati.eproc.in> within the period of tender submission:
20. Treasury Challan or Demand Draft or Pay Order or Banker's Cheque or Deposit at Call Receipt or FDR or Bank Guarantee against EMD and Copy of Enlistment Order and Certificate of work experience as required shall be scanned and uploaded to the e-tendering website within the period of tender submission.
21. Online tender documents submitted by intending tenderers shall be opened only of those tenderers, whose Earnest Money Deposit and e-Tender Processing Fee and other documents placed in the envelope are found in order.

The certified copy of all the scanned and uploaded documents specified in the tender notice shall be deposited by me/us with the Executive Engineer calling the tender in case I/We become the lowest tenderer within a week of the opening of the financial bid otherwise the department (CCW,AIR) may reject the Tender and take the action to Debar me/us from Tendering in CCW,AIR , for a period of three years and can write to the Competent Authority for cancellation of my/our enlistment (Original papers of the uploaded documents shall be shown for verification.
