SHORT NOTICE INVITING QUOTATION

The Executive Engineer (Civil), Civil Construction Wing, All India Radio, Mumbai-20, on behalf of the President of India invites quotations in sealed covers from approved and eligible Specialized agencies of Structural repairs and rehabilitation/Retrofitting works or approved and eligible contractors of C.P.W.D. and those on appropriate class of contractors enlisted in the Department of Telecommunications (BSNL / MTNL), Department of Post, M.E.S., Railways, State P.W.D. of Maharashtra/Goa as well as eligible working contractor of CCW : AIR for the following work, upto 1500 hrs. on 20.06.2023 which shall be opened on the same day at 1530 hrs. in the presence of intending bidders.

Name of work : External repairs including providing roofing to balconies, internal painting and misc. works in Holiday Home at AIR, HPT, Bambolim-Goa.
Sub-Head : Structural repairs, plinth protection including external plaster, cleaning and painting of external surface.

- The bid document consisting of schedule of quantities of item to be executed and terms and conditions of the contract to be complied with and other necessary documents can be seen on the website <https://prasarbharati.eproc.in>.
- The competent authority on behalf of the President of India does not bind himself to accept the lowest or any other quotation and reserves to himself the authority to reject any or all the quotations received without assigning any reason. All quotations, in which any of the prescribed conditions are not fulfilled or any condition including that of conditional rebate is put forth by the bidder shall be summarily rejected.
- Any claim of whatsoever nature shall not be entertained.

CONDITIONS OF THE CONTRACT :

- The work shall be carried out as per CPWD Specifications, 2019 Vol. I & II with upto-date correction slips and as per directions of Engineer-in-Charge;
- Time limit for completion of work is **45 (forty five) days**;
- Quoted rates are inclusive of all taxes and levies payable under the respective statutes including GST, nothing extra will be paid on any account;
- No extra payment shall be made on any account such as extra thickness of base coarse/depths and all height of buildings, etc.;
- All type of security measures / precautions of labour shall be responsibility of agency during execution of work. No extra payment will be made on any account;
- If the work is prolonged beyond stipulated time the penalty shall be imposed @ Rs.5000.00 per week;

7. The agency will be responsible for any defect for a period of 12 (twelve) months after issuing completion certificate for the work by Engineer-in-charge & client department. If any defect found during the defect liability period, the agency shall rectify the same within 7 days after receiving the notice from Engineer-in-charge in any form failing which the defective work shall be got rectified / replaced completely at the risk & cost of the agency and no claim whatsoever shall be entertained in this regards. The agency may note that the recovery shall be made from any of the payments due with the department or will be under legal obligation to refund the cost incurred by department in rectification / replacement of the defective work came to the notice of Engineer-in-charge during defect liability period;
8. 5% of the value of work done shall be retained from the bills of the agency as security money to watch the performance of the work during defect liability period. The same shall be released after completion of defect liability period on receipt of confirmation from the site Engineer-in-charge and the client department.
9. The Contractor is required to furnish a Guarantee Bond, on stamp paper of appropriate value, in the proforma attached, as guarantee for the Integral water proofing treatment/coating/painting of entire roof, chajja, sump well/OHT, external wall surface and other portions of the building, etc. as the case may be. Period of this Guarantee shall be 5 (Five) years to be reckoned from the date after the maintenance period prescribed in the contract Agreement. In addition to the above, 10% (ten percent) of the cost of the water proofing item/s shall be retained as guarantee money to watch the performance of the work done. However, half of the amount so retained would be released after three years and the balance after five years, if the performance of the work is found satisfactory. If any defects is noticed during the guarantee period, it should be rectified by the contractor within seven days of a Notice from the Department, and if not, the same will be got done through another agency at the risk and cost of the contractor.
10. Intending bidder is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works [similar works means the executed must include structural repairs to RCC members amounting to one lakh or more], of magnitude specified below, in the last seven years ending 31-06-2023. The works completed upto previous day of last date of submission of tender shall also be considered.

Three similar works each of value not less than ₹ 3.39 lakhs (Rupees three lakh thirty nine thousand only)

OR

Two similar works each of value not less than ₹ 5.08 lakhs (Rupees five lakh eight thousand only)

OR

One similar work of value not less than ₹ 6.78 lakhs (Rupees six lakh seventy eight thousand only)
