- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Informatic n and Instructions for bidders posted on website shall form part of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website <https://air.ewizard.in> free of cost.
- (i) The bidder should scan and upload the documents for financial instruments, such as Demand Draft or Pay order or Banker's Cheque or Deposit at call receipts of any schedule bank towards EMD in favour of "PB, BCI, EE(C)MHP Div., CCW,AIR, New Delhi" and e-tender processing fee as admissible shall be payable to M/s ITI Limited through e-gateway by Credit Card/Debit Card, Internet Banking or RTGS/NEFT facility.
 ii) The amount of EMD can be paid by Demand Draft/Pay Order /Banker's Cheque /Deposit at call receipt /FDR's of any schedule bank.
 iii) **Detailed procedure can be seen in the CPWD -6 for e-tendering.**
- Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
- On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- Contractor can upload documents in the form of JPG format and PDF format.

8. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0".

Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).

9. The contractor shall quote rates including work contract GST, other taxes, Cess and levies. However, GST shall be reflected in the tax invoice / bill separately.

10. **List of Documents to be scanned and uploaded within the period to tender submission.**

The following documents should mandatorily be uploaded so as to reflect in the front box of verifying documents of the tenderwizard.

- i) Affidavit as per clause 1.2.1 (b) of form CPWD-6 on non judicial stamp paper of Rs.100.
- ii) Affidavit as per clause-9 of form CPWD-6 on non judicial stamp paper of Rs.100 duly notarized.
- iii) Enlistment order / valid registration of the contractor.
- iv) Certificate of registration of GST and PAN.
- v) Certificate of work experience (issued by an authority not below the rank of Executive Engineer).
- vi) SC/ST Candidates upload the required document in support of their claim for exemption of EMD and other contractors should pay EMD online.
- vii) Latest GST return filed for last month / quarter.
- viii) Partnership Deed (if any) & Power of Attorney (if any).

(It is mandatory to upload scanned copies of all the documents, if one of these documents is not uploaded, then bid will become invalid and shall summarily be rejected).

The bidder shall be required to produce original documents for verification on demand by Assistant Engineer (Civil).

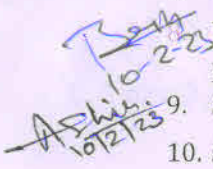
