- Time limit for completion of work is 15(Fifteen) days.
 Quoted rates shall be inclusive of all taxes and levies payable under the respective statutes
- 4. The Agency shall visit the site of work before quoting, as no extra payment will be made on any such as extra Thickness of base course/depths and all height of buildings etc. account
