1. Concerned Head of Offices/ADG(E), all Zones are requested to ensure that ADEs/DDEs/DEs of one /two year tenure difficult stations under their control should be relieved only after completion of their



- tenure. Officers of Stations other than tenured difficult stations should be relieved within ten days of issuance of transfer order or the date mentioned against them, if any.
- 2. Once the transfer representation against a particular order has been considered and a decision has been communicated, no further representation against the same order shall be considered by this Directorate at least up to 6 Months from the date of the decision communicated.
- 3. Request for transfers received in the Directorate is considered by the Transfer Committee in its meeting and orders are issued in respect of those where it is decided to accept the request. Once a transfer order in a particular Cadre has been issued after receipt of the representation or requests of transfer in that Cadre and the name of a person is not figured in that order, it may be presumed that the request has been rejected by the transfer committee.
