- 3] निविदा बोली (सील बंद बोली) में विशेष रूप से नियम और शर्तों का उल्लेख होना चाहिए नीलामी। उद्धृत बोली का उल्लेख अंकों एवं शब्दों में भी किया जाना चाहिए।

The tender should be submitted in **sealed cover** super-scribed as "**Tender bid offer for Sale of Metal Scrap/Junk**".

1. The tender shall be completed in all respect and should be signed with date by the Authorized Signatory of Tenderer on all the pages.
2. The offer prices shall be quoted for the scrap per kg basis "**AS IS WHERE IS BASIS**" plus GST@18% extra
3. The Tenderers are free to inspect the Scrap at the above address of **Akashvani campus, civil Line, Nagpur**, on any office working day from 19.10.2023 to 25.10.2023 in the presence of Akashvani official.
4. The tender shall be awarded based on the highest bid offer received for individual item. In other words, the successful bidder would be decided for each item based on the highest offer received for particular item. Accordingly the delivery of each item would be issued separately to selected bidder for that particular item. Up on award of the contract, the particular highest bidder shall deposit full amount of the actual value of the scrap item.

5. **Procedure for disposal of Scrap:**

- a) The successful Bidder/Tenderer shall deposit the total lump sum amount in Rupees for scrap as detailed under by way of Pay in cash OR DD in favor of "**PRASAR BHARATI , AO, AIR**" payable at Nagpur towards the cost of Scrap (approx) within 24 hour in working days from the date of awarding the sale order.

- 2] The Tender bid (Seal bid) will be opened in the office of the undersigned at **1500 hrs.** on **26/10/2023** or on the next working day, if **26/10/2023** happens to be a holiday, in the presence of bidders, Interested bidders may attend at the time of opening of tender bid.
- 3] The tender bid (Seal bid) should specifically mention the terms and conditions of Auction. The bid quoted should be mentioned in figures and words also.
- 4] The highest bidder shall sign a bid sheet on which proceedings of the auction are recorded in token of having offered the highest bid and abiding terms of auction.
