

**INFORMATION AND INSTRUCTIONS FOR BIDDERS FOR e-TENDERING
FORMING PART OF BID DOCUMENT AND TO BE POSTED ON WEBSITE**

The Executive Engineer (E), CCW, AIR, Mumbai on behalf of President of India invites e-tender from approved and eligible Licensed Agencies for the purpose of the Maharashtra Fire Prevention and Life Safety Measures Act, 2006 of EFA & Fire Fighting System for the work:

1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all documents required.
2. Information and instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting of plans, specifications, schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from the website <https://prasarbharati.eproc.in/> free of cost.
4. But the bid can only be submitted after depositing Processing Fee in favour of M/s. C1 India Pvt. Ltd and deposition of original EMD in the division office of Executive Engineer(E) CCW, AKASHVANI, PB(IPSB), Mumbai-20 or division office of any Executive Engineer (C/E), Civil Construction Wing, All India Radio, within the period of bid submission (The EMD document shall only be issued from the place in which the office of receiving division office is situated) and uploading the mandatory scanned documents such as Insurance Surety Bonds, Account Payee Demand Draft or Banker's Cheque or Fixed Deposit Receipt from any of the Commercial Banks towards EMD in favour of **Executive Engineer (E), CCW AIR PB(BCI), Mumbai-20**, receipt for deposition of original EMD to the Executive Engineer (E), CCW, AKASHVANI, PB(IPSB), Mumbai-20 or division office of any Executive Engineer (C/E), Civil Construction Wing, All India Radio, within the period of bid submission and other documents as specified. The FDR shall be accepted only if it is valid for a period of six months or more after date of opening of the Tender.
5. Detailed procedure can be seen in the CPWD-6 for e-Tendering
6. Contractors, who are not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the said website
7. The intending bidder must have valid **Class-III** Digital Signature to submit the bid.
8. On the date of opening of the Bid, the bidder can login and see the bid opening process. After opening of Bids he will receive the competitor bid sheets.
9. Bidder can upload documents in the JPG or PDF format.
10. SC/ST bidders enlisted under Class-V category are exempted from processing fee of e-Tender payable to M/s. C1 India Pvt. Ltd.

1	Copy of Account Payee Demand Draft/Bankers Cheque/Fixed Deposit Receipt from any of the Commercial banks or Insurance Surety Bonds against Earnest Money Deposit [Must be submitted as a single instrument].
2	Copy of receipt for deposition of original EMD issued from division office of any Executive Engineer (Including NIT issuing EE/AE), CCW, AKASHVANI, within the period of bid submission (The EMD document shall be issued from the place in which the office of receiving division office is situated)
3	Copy of Certificates of Work Experience , in the last seven years ending in Central Government, State Government, PSUs and other Government Local bodies. In case works are executed in Private Sector, then TDS Certificate for Income Tax for the works executed are also required to be submitted along with details of works of similar nature (Similar work means SITC or Maintenance of Early Fire alarm & Fire Fighting System) in Para 1.2 of Form CPWD 6
4	Copy of Certificate of Registration for GST or UNDERTAKING: If work is awarded to me, I/we shall obtain GST registration certificate as applicable within one month from the date of receipt of award letter or before release of any payment by CCW AKASHVANI, whichever is earlier, failing which I/we shall be responsible for any delay in payments which will be due towards me/us on account of the work executed and/or for any action taken by CCW AKASHVANI or GST department in this regard.
5	<u>Copy of Duly notarized Affidavit on Rupees 100/ Stamp Paper</u> NIT No: 09/NIT/SEE/CCW/NGP/2023-24 <i>I/We undertake and confirm that eligible similar work/s has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in CCW-AIR in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee.”</i> The certified copy of all the scanned and uploaded documents specified in the Press-Tender Notice/NIT shall be deposited by me/us with the Executive/Executive Engineer (Electrical), Civil Construction Wing, All India Radio, Mumbai-20, in case I/we become the lowest tender within a week of opening of the financial bid, otherwise the Department (CCW-AIR) may reject the tender and take action to debar me/us from tendering in CCW-AIR for a period of three years and can write to the Competent Authority for cancellation of my/our enlistment
6	<u>Copy of Valid Enlistment</u> Order of the Contractor as Licensed Agencies for the purpose of the Maharashtra Fire Prevention and Life Safety Measures Act, 2006 of EFA & Fire Fighting System
7	Copy of Certificate or Registration of EPF and ESI should be uploaded or in case the contractor feels that the EPF and ESI Acts are not applicable in his case and such registration certificates are not required for the work he shall upload the necessary undertaking to this effect
8	Copy of Acknowledgement of up to date filed returns for GST i.e. up to March, 2023
9	Copy of Valid Electrical contractors License
