The Executive Engineer(Civil)-II, CCW, AIR, 11th floor, Soochna Bhawan New Delhi on behalf of the President of India invite on line Item Rate e-tenders from eligible contractors of appropriate class registered with CPWD, MES, BSNL, Department of Posts, Railways and Delhi State PWD (B&R) **up to 11.00 AM on 09.01.2023** for the followings works :-

1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he consider himself eligible and he is in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website <https://air.ewizard.in.>, or www.eprocure.gov.in free of cost.
4. The bid can only be submitted after depositing of online EMD and processing Fee in favour of ITI Limited and other documents as specified. Unless all intending tenderer/bidders who have uploaded/submitted their bids by the last date of tender have submitted their online EMD which is verified from the issuing bank, tenders cannot be accepted and to be treated as invalid tender. The bidders already registered on the e-tendering portal will have option to continue by paying tender processing fee upto one year from the date of registration, or to switch over to (new) registration without tender processing fee any time. All new registrations from 01-04-2015 will be without tender processing fee.
5. **Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.**
6. The intending bidder must have valid class-III digital signature to submit the bid.
7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
8. The price bid shall be opened after verifying the documents. However, bidders shall have no option to submit the revised price bid, if so, desired by them. The price bid submitted earlier shall remain valid and opened on due date.
9. Contractor can upload documents in the form of JPG format and PDF format.

10. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).

11. SC/ST Contractors enlisted under class V category are exempted from processing fee payable to ITI
12. The contractor shall quote rates including work contract GST, other taxes, Cess and levies. However, GST shall be reflected in the tax invoice / bill separately.
