
1. **Category:** Associate (Admin)/ Senior Associate (Admin)/ Consultant (Admin)

3. **Place of work:** Prasar Bharati Secretariat & DG: DD News, New Delhi
4. **Duration of engagement:** One year
5. **Consolidated remuneration:** As per rules for Retired Govt. persons

 - i. A person who has retired from the Central government offices or Autonomous bodies under Central government at Pay level 5 to 11
 - ii. Applicant should be proficient in computers.
