Monthly Work:

Monthly inspection and service of package / Cassette AC unit as details below.

- 1. Check & Clean air filters & coils of condensers.
- 2. Checking of Refrigerant system
- 3. Maintain electrical controls & power distribution panel of packaged units.
- 4. Checking fan bearing for wear and tear.
- 5. Check condition of V-Belt and adjust its tension and replace with new one (Supplied by Office) if required.
- 6. Checking of thermal insulations and clean the drainage of sweat water.

Quarterly Work:

Quarterly inspection and service of package / Cassette unit as details below.

- 1. Check Compressor mounts for any undue vibrations of cracks, Replace mount if necessary.
- 2. Check operation of overload, HP/LP Cutouts, Single Phase Preventer and check thermostat Operation.
- 3. Check operating pressure of compressor.
- 4. Clean condenser / evaporator coil with chemicals.
- 5. Carryout leak test for refrigerant.
- 6. Lubricate fan motors.
- 7. Align pulleys and check level of shafts.

In addition to above, if breakdown occurs, firm has to attend the faults on call basis as and when required, it includes labour charges involved in leakage testing, gas charging, compressor replacement and related works.
