- 11. The time allowed for carrying out the work will be O3(Three) Days from the date of Work Order.
- 12. Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their quotations as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender / bid. A quotationer / bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The quotationer / bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a quotation by a quotationer/bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.
- 13. The work in general shall be carried out as per latest CPWD book of specifications.
- 14. The competent authority on behalf of the President of India does not bind itself to accept the lowest or any other tender / bid and reserves to itself the authority to reject any or all the quotations / bids received without the assignment of any reason. All quotations in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer / bidder shall be summarily rejected.
- 15. The quotation for the works shall remain open for acceptance for a period of 10 (ten) days from the date of opening of quotation. If any quotationer / bidder withdraws his quotation before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the quotation which are not acceptable to the department, in such case, the quotationer shall not be allowed to participate in the retendering process of the work.
