When an application under RTI Act, 2005 is forwarded to the concerned CPIO and at the time of examining the application, it is observed by that CPIO that, part of the information sought relates to another CPIO, or the information sought does not relate to her/him, she/he shall transfer the application to the concerned CPIO, under Section 6(3) within 5 days from the date of the receipt of application for providing a reply to that part of information to the applicant. The applicant should be informed about such transfer.

All CPIOs & FAAs are requested to regularly check RTI MIS Portal for tracking RTI applications transferred to them for furnishing reply directly to the applicants/appellants respectively.
