- 1. All the CPIOs will be required to intimate the details of RTI applications received by them in previous month and status of the same by first week of every month. CPIO can declare a suitable officer of his station/office as CAPIO to assist him and details may be sent to Zonal Office within 15 days of receipt of this order. HOEs/HOPs/DDOs of respective stations/kendras will be the DPIOs for Engineering/Programme/Administration and Accounts functions respectively and will be responsible for providing the complete and certified information to CPIOs within time.
- 2. In case any CPIO/Appellate Authority is on leave or tour, the officer-in-charge who is looking after his/her works, will act as CPIO/Appellate Authority for all such assignments.
- 3. When an application under RTI Act, 2005 is forwarded to the concerned CPIO and at the time of examining the application, it is observed by that CPIO, that, part of the information sought relates to another CPIO, or the information sought does not relate to her/him, she/he shall transfer the application to the concerned CPIO within 5 days of the receipt of application for providing a reply to that part of information to the applicant. The applicant should be informed about such transfer.

- 4. All CPIOs and Appellate Authorities are hereby authorized to attend all hearings of the cases related to them before the Central Information Commissioners whenever they receive notice from them. All the CPIOs and Appellate Authorities are requested to present themselves as CPIO and Appellate Authority as the case may be, along-with their normal official designations in all
- 5. All CPIOs and FAAs are requested to regularly check RTI MIS portal for tracking RTI aplications transferred to them for furnishing reply directly to the applicants/appellants respectively.
