Generally, the information if not provided to the RTI applicant within the specified time of 30 days is considered as the information denied and there is provision for penal action for delay in furnishing of the information/ reply to the RTI applicant which is @ Rs.250/- per day subject to a maximum of Rs.25000/- in each case.

In view of the above, it is requested that : -

- Suitable instructions may please be issued to all concerned CPIOs for immediate disposal of pending RTI applications as per provisions of RTI Act 2005 which may otherwise invite penal action against the respective CPIOs.
- In case any CPIO / FAA has been changed/ transferred, the Head Of office of the respective/ kendra is to ensure that the RTI application/ Ist appea is taken care of and replied by the new CPIO/FAA for its disposal in accordance with the provisions of RTI Act-2005 in a time bound manner.
- 3. Suitable instruction may also please be issued for submission of written statement to the Hon'ble CIC and attending the hearing in CIC by concerned CPIO(s) without fail as and when the notice of hearing is received from the O/o the CIC.
- 4. Updated list of CPIOs and FAAs may also be furnished to this office in view of the transfer/promotion/change of work allocation/superannuation of various CPIOs/FAAs in the recent past. The updated list may please be communicated through email at rticellpbs@prasarbharati.gov.in to enable this office to issue the user ID and Passwords to the new CPIOs/ FAAs to access RTI MIS portal.

Close monitoring of the RTI matters and periodical review is solicited to ensure timely compliance of provisions of RTI Act 2005 regarding RTI applications and First Appeals.
