1. In case any CPIO/Appellate Authority is transferred or superannuated, then the officer who is given charge, or the new incumbent to the post will act as CPIO/Appellate Authority in respect of such assignments.

2. In case any CPIO/Appellate Authority in the Directorate is on leave or tour, the officer-in-charge who is looking after the works, will act as CPIO/Appellate Authority for all such assignments.

- **3.** When an application under RTI Act, 2005 is forwarded to the concerned CPIO and at the time of examining the application, it is observed by that CPIO that, part of the information sought relates to another CPIO, or the information sought does not relate to her/ him, s/he shall transfer the application to the concerned CPIO within 5 days of the receipt of application for providing a reply to that part of information to the applicant. The applicant should be informed about such transfer.
- 4. All CPIOs and Appellate Authorities are hereby authorized to represent Director General: All India Radio in all hearings of the cases related to them before the Central Information Commissioners whenever they receive notice from them. All the CPIOs and Appellate Authorities are requested to present themselves as CPIO and Appellate Authority as the case may be, along-with their normal official designations in all communications in RTI matters.
- 5. All CPIOs are requested to regularly check RTI MIS portal for tracking RTI applications transferred to them for furnishing reply directly to the applicants/appellants respectively.
